The EQ basin is being cleaned by Industrial Vacuum Services from North Carolina. They are removed the sludge and grit in preparation for the new plant startup. Ovivo has been onsite modifying the framing and cassettes in the MBR tank.

Mr. Miller reported the PER was submitted to the Virginia Department of Health on May 1st as required in the Consent Order for the Schuyler Water Treatment Plant TTHM compliance issue. The PER recommends a phase in approach. VDH reviewed the document and suggested revisions to provide more detail and clarification by June 7, 2024.
