Mrs. Fitzgerald stated she is working with Rural Development to get the items on the Letter of Conditions satisfied.

Mrs. Fitzgerald stated she received the formal approval letter from Southeast Rural Community Assistance Project (SERCAP) for \$50,000 to assist with the Schuyler WTP TTHM project.

Mrs. Fitzgerald reported that Synagro will be coming for a site visit to give a quote for dredging at the Black Creek Reservoir.

Mrs. Fitzgerald stated there are no updates

on the Larkin Property project.

AGENDA ITEM 3. EXECUTIVE DIRECTOR'S REPORT

Mr. Miller reported the progress meeting for the Wintergreen WWTP project was held yesterday. An updated schedule was provided from English Construction reflecting a final completion date of February 9, 2025. Ovivo is waiting on sample results before moving forward with starting up the new plant. The Wintergreen WWTP received 26.2" of rain in 16 days, which is being documented as a 1000-year rain event.

Mr. Miller reported originally Aria Filtra (formerly, Pall Corp.) was scheduled to visit the Schuyler WTP on October 1st. However, after further discussion with staff it was decided that extensive sampling needs to be done prior to a technician coming onsite. Our operator is currently in the process of taking samples and getting them mailed off to the Aria Filtra labs in Canada for analysis.

AGENDA ITEM 4. SYSTEM MAPPING

Mrs. Fitzgerald stated the lead service line inventory has been formally submitted to the state for review. This information was due by October 16th. Mrs. Fitzgerald also read an email from VDH about this program, that if your program cannot meet this funding program deadline to submit a revised project schedule by December 31, 2024.

AGENDA ITEM 5. DIRECTOR'S COMMENTS

Mr. McSwain stated he and Mr. Reed attended the last Black/Hat Creek meeting. He stated that when the new permit is issued for the Regional STP there will be a phosphorus limit.

Mr. Hight stated that he and Mr. McSwain met with Mr. Carlton Ballowe and Mr. Larry Saunders with the Nelson County EDA about future growth in Nelson County. The EDA members wanted to know about the capacity of the Service Authority's water and sewer facilities.

Mr. Shimp suggested that the County should investigate a shallow drip system instead of a reservoir as an option for water on the Larkin Property. He stated the wells will be recharged by the sewer effluent.
