### AGENDA ITEM 3. EXECUTIVE DIRECTOR'S REPORT

Mr. Miller reported the progress meeting for the Wintergreen WWTP project was held yesterday. The sub-contractors have been clean water testing the equipment and started up the hoist in the MBR building. The next couple of weeks the operators will have mechanical and instrumentation training. In August, the schedule shows the contractor is 125 days past due with substantial completion estimated to be December 9<sup>th</sup> and final completion on January 8, 2025. As of yesterday, we were told those dates need to be pushed back an additional 2 weeks due to setbacks.

Mr. Miller reported the maintenance staff installed a 2" static mixer on the AP2 membrane equipment in Schuyler to ensure mixing under almost all scenarios and will minimize any slugs of chemical feeding directly to the membranes. The Aria Filtra personnel is scheduled to be onsite in October.

Mr. McSwain would like an update on the sewer issue at the Bailey Spencer building in Lovingston after Mr. Miller meets with the customer.

Mr. Reed took a self-guided tour of Lovingston noticing the Dawson well site and the oil tanks along Town Creek. Mr. Reed mentioned the Resolution for the Lovingston sewer project was approved at the last Board of Supervisors meeting.

Mr. Sanchez stated he had been approached by a customer in Gladstone in reference to changing the rate structure to allow for more gallons allowed for the minimum charge. Mr. Shimp stated the time to approach changes to the rate structure is when the budget is presented. Mr. Sanchez also requested information about what would it take to put in a suppression system in Gladstone. Mr. Miller stated the current spring feed water system would not support a fire suppression system because there is only a 5,000-gallon tank there and that would be depleted within minutes if a fire truck hooked to it. Mr. Miller suggested maybe the County could put in a pumping station at the James River to service the community.
